

# Hidalgo and Starr County nonprofits to receive help from federal grant

## Informational meetings will cover new grants and training opportunities for nonprofits

The University of Texas-Pan American's Southwest Border Nonprofit Resource Center (SBNRC) has been selected to receive almost a \$1 million to strengthen operations of nonprofit organizations in Hidalgo and Starr counties so they can provide assistance to residents affected by the economic downturn.

The local contribution is part of a \$46 million grant that has been awarded to 84 grantees nationwide by the U.S. Department of Health and Human Services (HHS) under a new program called Strengthening Communities Fund (SCF), created by the American Recovery and Reinvestment Act.

The local funds will be overseen by SBNRC's Stronger Together Initiative (STI). The UTPA program is one of only four in Texas to receive the monetary award and the recipient of the largest grant

which totals \$982,111. Of this amount, \$600,000 will be available in the form of competitive grants and awarded to nonprofits that apply for the funding and meet certain criteria. The remaining funds will be provided to groups considered for non competitive funding.

In all, STI hopes to assist up to 50 nonprofits in Hidalgo and Starr Counties. The program will target faith and community based organizations such as church food

pantries and adult literacy centers. Those competing for grants will be given priority if they have annual budgets of \$500,000 or less and work collaboratively with agencies administering funds and programs under the Temporary Assistance for Needy Families.

The funding, if awarded, will allow SBNRC to train nonprofits in the areas of organizational, leadership, strategic and program development for one full year. They will also be eligible for intensive technical assistance and cash grants from \$10,000 to \$20,000. Noncompetitive groups that qualify will receive training and technical assistance for two years at no cost to them.

STI says the idea is to provide the nonprofits with the expertise they need to be able to assist low-income individuals secure and retain employment, earn higher wages, obtain better-quality jobs, and gain greater access to state and federal benefits and tax credits.
